- o Fountain maintenance seems to be ok for now, so we put this on hold for now.

New Business

- Rain gauge issues perhaps we need a water evaluation and recommendations. Sandie will contact the city to see if Jennifer Nations can come and speak at our annual meeting. We can also discuss the need to adjust sprinkler setting or turn unit off in the case where homeowners do not have rain detection gauges. J R agreed to contact an engineer to obtain information/estimates on installing a storm drain at the end of the south cul-de-sac that would connect to the existing storm drain at the Torres house, hopefully allowing residents that currently pump into the street to connect to the new storm pipe directly.
- Youker Vitex tree note \$3,243. We should have enough reserve funds to pay this off at the end of the year.
- Future road maintenance. JR shared concrete prices, and we all agreed that it is out of our budget. Other options were discussed.
- Gas lamps more than 80% are not lit. Could we find a plumber to give us a bid to inspect, repair, and light all of them – at each home owners' discretion and independent billing? Sandie said she would contact someone and share the number.
- The Gardens' 2021 Annual Meeting will be held on Wednesday, September 8th, 2021 at 6:30PM. We will reach out to the social committee to possibly plan an event.
