All,

We received two bids, one from the Houston group and one from the local group. They were within \$100.00 of each other for identical pumps, \$5,100.00 plus an estimated \$750.00 for upgrades by the electricians. I recommend we purchase from the local company ...Trophy Fisheries (Daniel Hoffmon) for servicing and being a local business. He's also been recommended by both Sandie and Amy.

The new pump will be the same 1/2 hp, and include a new underwater electrical cable, 3 different spray pattern options, a color changing 4 light kit with remote and a new control panel for the pump.

Delivery will be approximately 10 days once we approve and they order the pump.

A solar power option was considered as well. I was told that solar is not as efficient as AC power, costs about \$1,700 more, solar panels would be unsightly and would not recover until around 9:00am each morning. So that's out. It's really designed for ponds without AC accessibility.

Financially, our budget has approximately \$7,800 designated for special projects. That's where the funds will come from. We will still have an estimated \$14,500.00 in our cash reserves/maintenance funds account. (Sandie ... please correct me if I've missed quoted any of the numbers!)
