Research on the plants and what to do next

Last year we had a wish list – drop ideas in the box. Let's do it again this year.

Last year – paint lamps, social events, and entry pavers. All of these were completed.

Community spring landscape day – possibly collaborating with Green Teams.

# Accomplishments:

Pavers, paint lamps, sunshade on code box, postings in Group Me, Social events have been fun, lots of irrigation repairs done and need to do, beds at entrance – Youkers added the plants via donation, Junipers – we think we have answers for the blight/fungus and will coordinate treatment.

### Projects:

Perhaps add a sign at entrance for meeting in addition to email and app? Big gates need to be painted.

- a. Proposed 2024 Budget Available at the website.
- b. Projects to discuss:
  - 1. Junipers at entrance plan for trim and treatment.
  - 2. Water pooling at exit around pavers broken irrigation head and add drain. Estimate to repair is about \$1800
  - 3. Water leak at supply to cul de sac off for now, needs a repair. Estimate repair is about \$1600
  - 4. Landscaping committee is hard at work doing research. Clarity: focus is on dead/dying crepe myrtles around the pond, dead ground cover, irrigation -problems with ineffective water patterns, create a heartier landscape in the long run. \*With a focus on the budget.
  - 5. Entrance keypad. Talked about replacing the system. We are looking into replacing the screen. In the meantime, we will post a directory on paper at the box. HOA office looking for the key and Kade will assist with research.
  - 6. Water issues and solution options have been discussed in relation to street damage and necessary repairs.
